Boot Brush Kiosk Installations

Have you ever been out walking and noticed all of the prickly, little thorns getting stuck in your shoes? You probably ran into Puncturevine, or more commonly known as Goatheads. These small nuisances are just one of the many noxious weeds native to Colorado. Noxious weeds are invasive species which can severely impact



the native plant life and habitat. Species like Puncturevine travel and spread through those annoying thorns, from the trail, to your shoes, to your backyard, to your local park, and so on. Soon, they can be everywhere and quickly wipe out the native plant species. That is why it is important to be aware of what noxious weeds you may be spreading while you are out hiking, walking, or enjoying the outdoors. The new boot brush kiosk at Riverside Park is a joint effort between the City of Fort Morgan Parks Department and Morgan Conservation District to target and combat noxious

Conservation Stewardship Program Requirements

NRCS Conservation Stewardship Program (CSP) helps you build on your existing conservation efforts while strengthening your operation. Whether you are looking to improve grazing conditions, increase crop resiliency, or develop wildlife habitat, we can custom design a CSP plan to help you meet those goals. We can help you identify natural resource problems in your operation and provide technical and financial assistance to solve those problems or attain higher stewardship levels in an environmentally beneficial and cost-effective manner. For example, we can look at ways to address the amount of soil lost; mitigate the impact of excess water; reduce the contribution of agricultural operations to airborne soil particles and greenhouse gas emissions; improve the cover, food, and water available for domestic and wildlife species; or promote energy efficiencies for on-farm activities. If you are already taking steps to improve the condition of the land, chances are CSP can help you find new ways to meet your goals.

The following is a list of items required with your application in order to be considered.

- FSA farm records must be updated for the applicants AGI, 1026, HEL. Entity documents must be in place prior to application that outlines signature authority.
- Maps must be presented with the application including acres and land-use
- Lease agreements must be presented with the application outlining the years the applicant has control of the land and must cover the length of the contract period.
- Landowner concurrence forms must be submitted with application
- Baseline farming practices i.e. tillage, nutrient mgmt., pest mgmt., water mgmt., Range mgmt. practices must be presented with the application i.e. number of cattle, rotation etc.


New Private Lands Wildlife Biologist in the Fort Morgan NRCS office

Butternut Squash Soup

Chef Jason K. Morse, CEC, 5280 Culinary, LLC and Ace Hardware Grill Expert

2 Tbsp. Olive Oil

1-1/2 ea. Yellow Onion, diced small

2 Stalks Celery, with leaves, diced small

2 ea. Carrots, diced small

3 ea. Yukon Gold Potatoes, peeled and cubed

2 ea. Butternut Squash, seeded, roasted, chilled and peeled

48 fl. oz. Chicken Broth

1 tsp. Herbs de Provence

Kosher Salt to taste

Ground Black Pepper to taste

Pumpkin Pie Spice to taste

1-1/2 cups Whipping Cream

Heat large sauté pan, add oil and heat, then add the onions and cook until caramelized. Add the celery, carrot and potato and cook until the celery is translucent. Add herbs and spices, squash and broth, then bring mixture to a boil, turn down and simmer until all vegetables are soft. Using a hand blender puree the mixture until smooth. Finish with the heavy cream and adjust seasonings as needed. Great served with pumpkin spice bread.

Enjoy with a Colorado wine, such as a glass of Gewurztraminer, from Stone Cottage Cellars, located in Paonia, Colorado.
